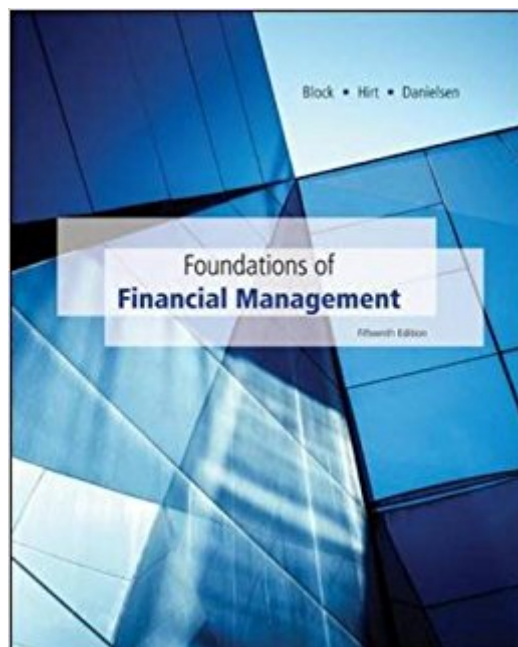

The sixth edition of Fundamentals of Investment Management was released in July 1998 and is published by Irwin/McGraw-Hill. Additionally, Geoff is well known for his book Fundamentals of Financial Management published by Irwin/McGraw-Hill. Now in its eighth edition, this book is

used at over 600 colleges and universities worldwide, and it has been translated into Chinese, Japanese, and Spanish. Geoff plays tennis and golf, is a music lover, and enjoys travelling with his wife, Linda.

One of the worst textbooks I've ever used. They make no use of the margins for explaining terms or trying to be remotely interesting. The chapters in this book are comprised of massive walls of text with a few bolded words and graphs. The real issue is this: they do not even explain how to do many of the end-of-chapter problems. Instead of referencing page numbers next to problems for explanations, they list their learning objectives at the start of the chapter, which are not even pointed out in the text as they are addressed. Extremely disappointed.

Seller sent the book and I received it on time. The rating is based on the book's content. The writers did not do a very good job, the technical writing was poor, and not outlined very well. They used the wrong wording in the questions. Clarity was not there. There were also not a lot of images of examples to keep you up to speed. Thank goodness for YouTube and the people who have taken the time to teach in 5 minutes what it took me hours to decipher in this POS text. I would recommend that any college that chooses to use this book seriously considers their accreditation policies because this was the worst.
