Please note I'm not reviewing the physical book, I'm reviewing the contents. This textbook is literally what is wrong with law schools and the instruction they attempt. There is a need for law students to know how to read cases, of course; you will, however, have three years of case reading in which to accomplish this. It seems this casebook's writers felt otherwise, and that if you don't read until your eyes bleed, you're not doing it right. This text frequently contained unabridged cases making up more reading per class than all my other classes combined. This was not due to the professor (excepting that he chose the text), but to the unnecessary length of the passages.

For the book, it is a nice book with an organized table of contents and it's easy to follow. My complaints are with the actual font (very straining on the eyes since it's small and curvy), and the actual shipment. I purchased it new and it came dented and a little scratched which is irritating since the money I paid for, I expected shrink wrap or a protective cover to protect the book. There was none.

This is an awesome book and a really good selection of cases and clear notes to them. My professor did not necessarily followed the book, although it was mandatory, but I used it for my exam preparation and I couldn't be better.

It's a law school casebook, so if you're reading this, you probably don't actually have a choice whether or not to buy it anyway. For what it's worth, though, this is a pretty good casebook. It has a lot of good example cases in the notes, and does a pretty good job choosing secondary sources to discuss the most complex issues.
