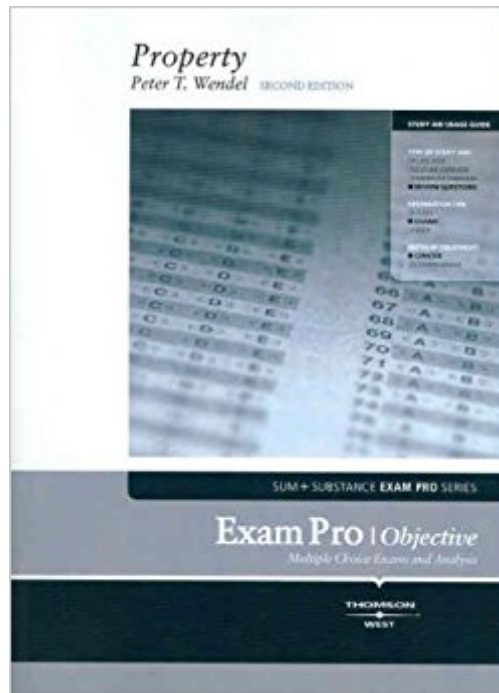

This book contains a lot of good practice problems and explains them in such detail that you can practically learn straight from it. I've only used it for a few topics so far and can say that it actually over explains a lot of things. This sounds dumb but sometimes when the problem is just trying to see if you recognize one or two small things, you don't need to go and explain the entire theory of property for every explanation, as this book does. It actually makes it harder to figure out why the answer is what it is. For future editions I'd suggest more problems and less wordy explanations.

My Property professor suggested that we get a copy of Exam Pro to prepare for her final exam, so I did. It was very helpful especially when it came to the future interest and RAP questions. Professors like to test on common law vs. modern law and this book had a handful of questions testing the "evolution" of certain legal concepts. I would recommend it to any 1L who is taking a MC final/midterm. The explanations in the back are thorough. I don't think it's all that useful for an essay only exam.

My Professor told us to get this book. It was really helpful on her exam, she use a few of the multiple choices questions. It was a little difficult to find the problems that were on our exam but the questions were great and the explanations in the back resolved some issues in our study group.
